



Fee and Aesthetic

Rent:

The rent is \$338.00 per month, payable on or before the 1st of the month. Any rent not received by the 5th will be considered late. If the rent is 30 days past due, a \$10.00 late fee will be applied. If a check is returned due to insufficient funds, a \$30.00 fee will be charged.

Rent payments must be made by personal check or bank deposit. (Please check with the administrator for the available bank account details for deposits.)

Note: For new contracts starting January 1, 2024, the rent will be \$650.00 per month.

Charges or Fees:

- a. If, after a 10 day notice, yard work and/or lawn mowing has not been completed, the tenant will be charged the fee stated in the 10 day notice.
- b. If, after a 10 day notice, repairs have not been made to your mobile home or other structure the tenant will be charged the amount stated in the 10 day notice for the repairs.
- c. The homeowner is responsible for the payment of all electric, gas and oil for their mobile home.












Main Water Supply:

If it is necessary to shut off the main water supply due to maintenance or an extended trip, the tenant must notify the property manager or owners in advance via email. (Contact: contact@bartowpark.com)

Aesthetic Standards for Mobile Homes:

- a. **Skirting:** The mobile home requires skirting from the bottom of the mobile home to the ground. The skirting shall be made specifically for manufactured mobile homes.
- b. **Colors:** No bright or bold colors allowed. Colors should be muted, country setting colors.

- c. **Porches:** There can be 2 porches on the mobile home. One porch can be up to 8 feet square. The second can be up to 8x16 feet. If there are more than 2 doors into the mobile home, the others can only have steps unless they both fall within the size of the second porch. Both porches can have roofs, but not required. Under no circumstances can a livable (wired, plumbed and/or insulated) room be added on to the mobile home.

- d. **Sheds:** One shed, for storage only, is allowed. The structure can be no more than 8x12 feet.

- e. **Common Areas:** The road in and out of the park is the common area. The road up to the main house is not a common area. The land beyond the gate is not a common area. No one under 18 years old is allowed beyond the gate without permission.

- f. **Driveway:** Each unit is responsible for its driveway - the resident is responsible for cleaning, cutting the grass and removing snow to access their home.

- g. **Parking:**
 - Each unit has one designated parking area.
 - Boats, trailers, and recreational vehicles must be parked in the area designated by the park administrator.
 - An extra fee will be charged for these vehicles.
 - Please confirm with the administrator before adding any of these vehicles to the parking area.
